

## LOOK What We're Planning for YOU!

PLAN COMMISSION TO HOLD PUBLIC MEETING ON LAND USE

The City of Wood River, utilizing the City Planning Commission, is in the process of revising its Comprehensive Plan with a primary focus on land use. A comprehensive plan is a city's guide to development. future growth and contains information about the future use of land, streets and transportation and community facilities. This plan is the first step in updating the City's zoning map. The new zoning map will be based on this Comprehensive Plan and its land use goals. A copy of the land use map is included in this issue of the Pipeline.

The present Plan is more than 10 years old and the advent of the relocation of Route 143 caused the City to re-examine its Plan. The new Plan focuses attention on the future of "Old Edwardsville Road" (the present route of Highway 143) and how to approach development in that, as well as the new corridor.

After the relocation discussions were completed, these two areas were then viewed in context with the entire Ciry. The enclosed map reflects the Planning Commission's preliminary concept for the future and the goals stated next reflect the City's attitude for the future.

The following goals for the new Comprehensive Plan were compiled at a work session with the City Council, Planning Commission, City Personnel and Planning consultants. These goals were accepted by the City Council as a basis for the new Comprehensive Plan.

the area of Economic Development include:

The development and pursuit of programs to bring about expanded economic development activities which include new investment opportunities.

The attraction of new and expanded facilities and the retention of existing establishments to provide increased employment opportunities.

Bring about a strengthening of the

community's tax base.

Stabilize the Central Business District and other retail sections of the community that are to be retained as part of the future land use plan for the City.

Encourage governmental participation in the economic development process.

Goals for the City of Wood River in the area of Community Spirit include:

Actively promote a strengthened Community image both among the City's residents and to the region.

Maintain a positive public relations position concerning the City.

Accept and strengthen the posture of regional leadership among communities in the Illinois portion of the metropolitan area.

Encourage among all the residents a strong feeling of community responsibility and pride.

Support a meaningful program for citizen's participation in local government activities.

To develop an active program to improve and maintain overall community appearance.

### from Your City Inspectors

Winter is on the way so we suspect that many of you will be stocking up on firewood. We would like to remind you that there is a City ordinance which requires firewood to be stacked 8 inches off the ground. This will keep firewood free from pests such as mites and rodents.

This Fall, we had to send out a number of brush and limb notices. A brush pile is unsightly and often prevents you from taking proper care of your lawn. Brush and limbs can be removed from your yard with a little effort - simply cut them in approximately 3 foot lengths, and tie them in bundles. These bundles can be set out with your trash to be picked up. OR you can take the brush to the City brush lot on North Walcott at the very end of the road. There is no charge for dumping brush at this lot.

### Parking of Trailers

Recently, the City has received complaints regarding numerous trailers parked illegally around town. For your information, City ordinance states that travel trailers, utility/boat trailers, etc. must be parked in rear yard or Therefore, the City Inspectors will contacting all those who are violating this law.

If you have no access to your back yard, please make some type of arrangements for storage.

## ₹ ₹ ₹ Powering the Levy

For the second time in Wood River's history, the City Council has adopted a levy reduction for property taxes being collected this Fall. The reduced levy is designed to help the City become less dependent on property tax revenue since its tax base has been steadily declining.

This levy assumes a total City valuation of \$60 million. Based on an actual total valuation of \$65 million, tax rates are expected to decrease from \$1.435 per \$100 assessed valuation last year down to \$1.317 this year.

The levy was reduced despite a continued drop in the City's tax base, due mainly to the closing of the Amoco Oil Refinery in 1981. State legislation which provides shelters and tax breaks to citizens will also effect the amount of property tax revenue the City will ceive. Even though the levy is being luced, no employee layoffs or cuts in city services are expected.

Below you will find a breakdown of the amount levied in departments whose appropriations have been reduced or remain unchanged:

\*Parks & Rec. - \$54,000, unchanged

\*Emergency Serv. - \$3,100, unchanged

\*Police - \$45,000, unchanged

\*Fire - \$45,000, unchanged

\*Municipal Band - \$6,000, unchanged

\*Insurance - \$45,000, unchanged

\*Police Pensions - \$51,259, reduced

\*Fire Pensions - \$51,259, reduced

\*Retirement - \$136,500, reduced



## Handicapped Accessibility

### **Announcement**

This notice is published pursuant to the requirements of Section 51.55 of the Revenue Sharing Regulations, as published in the Federal Register on October 17, 1983. Section 51.55 prohibits discrimination against qualified individuals because of their handicapped status.

The City of Wood River, Illinois, advises the public, employees and job applicants that it does not discriminate on the basis of handicapped status in admission or access to, or treatment or employment in, its programs and activities.

## Handicapped Accessibility Grievance Procedure

The City of Wood River has adopted an internal grievance procedure providing for prompt and equitable resolution of complaints alleging any action prohibited by the Office of Revenue Sharregulations (31 C.F.R. ing's (ORS), 51.55(d) (2) implementing Section 504 of the Rehabilitation Act of 1973, as amended (29 U.S.C.794). Section 504 "no otherwise states, in part, that individual... handicapped gualified shall, solely by reason of his handicap, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or federal financial activity receiving assistance..."

The City Manager has been designated to coordinate Section 504 compliance efforts.

- 1. A complaint should be filed in writing, contain the name, address and phone number of the person filing it and briefly describe the alleged violation of the regulations, including the discriminating party, the basis of the complaint and the date of the alleged violation.
- 2. A complaint should be filed within 5 days after the complainant becomes aware of the alleged violation. (Processing of allegations of discrimination occuring before this grievance procedure was in place will be considered on a case-by-case basis.)
- 3. An investigation, as may be appropriate, shall follow a filing of a The investigation will be complaint. conducted by the Handicap Accessibility Committee. These rules contemplate informal but thorough investigations, afforded by all interested persons and their representatives, if any, an opportunity to submit evidence relevant to a Under 31 C.F.R. 51.55 (d) complaint. (2), the City of Wood River, Illinois, complaints from not process need employment or from applicants for applicants admission to for secondary educational institutions.
- 4. A written determination as the validity of the complaint and description of resolution, if any, shall be issued by the City Manager and a copy forwarded to the complaintant no later than 10 days after its filing.
- 5. The City Manager shall maintain the files and records of the City of Wood River relating to the complaints filed.
- 6. The complaintant can request a reconsideration of the case in instances where he or she is dissatisfied with the resolution. The request for reconsideration should be made within 5 days to the City Manager.
- 7. The right of a person to a prompt and equitable resolution of the complaint filed hereunder shall not be impaired by the person's pursuit of other remedies such as the filing of a Section 504 complaint with the Office of Revenue Sharing, U. S. Department of the Treasury. Utilization of this grievance procedure is not a prerequisite to the pursuit of other remedies.
- 8. These rules shall be construted protect the substantive rights interested persons, meet due process standards and assure that the City of Wood River, Illinois, comply with Section 504 and the ORS regulations.


The results of this survey will be used to help the City gain an understanding of what it can do to make its programs, facilities and services more accessible to the handicapped. Please mail your completed survey to:


