SLIDING INTO SUMMER FUN

History is in the making in the City of Wood River! The first phase of the Central Park Aquatic Center is now in operation. The "Rainbow Bend" Water Slide opened June 9th. Construction continues according to schedule on the remainder of the aquatic center.

Here are some answers to questions frequently asked about the aquatic center.

- What were the problems associ-1. ated with the old pool? There is a misconception that the old swimming pool operated on a break-even basis. the old pool required fact. \$200,000 in property tax subsidies since The subsidies averaged nearly \$15,000 per season, or almost \$200 per The old pool day of each swim season. used an enormous amount of water. This situation was complicated by the deterioration and obsolescence of the pool. The average lifespan of a public swimming pool is just over 20 years. Our pool lasted nearly three times that long, with only one major renovation.
- 2. Who was involved in the decision to build a new Aquatic Center? In an effort to find a long-term solution to the swimming pool issues, the City Council appointed a 43-member Blue Ribbon Citizens Swimming Pool Advisory Committee. The committee began work in The citizens on the December, 1982. Advisory Committee represented a good cross-section of the community, and a variety of viewpoints on the future of A majority of the swimming facilities. committee, in the beginning of the independent study, believed the old pool During the study, could be salvaged. including architectural consultations, the vast majority of committee members concluded it would not be feasible to renovate the old pool. The construction cost for renovating the old pool would have been over \$780,000 more than the

cost of the new aquatic center. The estimated operating cost for a renoval pool would have been 60% higher, \$16,000 per year more than for the new pool.

- 3. How did the Committee reach its decision? The committee commissioned a study of what similar communities had decided when considering either renovation or a new swimming pool. Committee members toured public and private swimming pools in Belleville, Highland, Centralia, Urbana and Champaign. The committee members asked questions and took notes about the good points and mistakes in these projects.
- 4. What did the committee recommend to the City Council? Upon completion of the study, the committee voted unanimously to recommend construction of the Central Park Aquatic Center. aquatic center will include a swimming pool and deck area with a design capacity to serve more than 1,300 people. The deck area may be used for a variety of activities. The community pool for small includes a wading children. Facilities will be available for the swimming of laps, competit swimming and diving.
- 5. What did our City Council think about the citizen committee's recommendation? The City Council held two public hearings to gather more information about the aquatic center. The Council, following careful consideration of the financial prospects, approved the citizens committee recommendation.
- How will the Central Park 6. Aquatic Center be financed? The \$2,539,000 aquatic center will not require a tax increase. The financing package includes a grant of \$200,000 from the Illinois Department of Conserand a \$250,000 grant from the vation Community Development Madison County Agency. The major component of financing is a \$2.1 million lease/purchase agreement with the First National Bank of Wood River. This 10-year agreement calls for City annual payments ranging from \$345,000 in the first year to \$207,000 in the tenth year.
- 7. How will the City meet this annual financial obligation? The water slide is the primary source for payback. The water slide is project to generate a profit of more than \$100,000 per year.

Prior to the opening of the "Rainbow Bend" Water Slide, many residents of Wood River and nearby towns had to travel 20 miles or more to ride water slides. Now, citizens of Wood River and nearby communities are coming to the "Rainbow Bend" Water Slide. Those who use the water slide are helping to pay for the aquatic center.

Other sources of funds involve a series of paybacks on loans made by the General Fund and the Federal Revenue Sharing Fund to various "business" funds in past years to assist in development of their facilities. The Golf Course, Water and Sewer Funds are now able to begin repayment of these loans without increasing user fees. Since long-term bonds are about to be repaid in each fund:


- 1. The long-term water revenue bond was completed earlier this year with a final payment of \$67,000.
- The long-term sewer bond will be completed in two years with a final payment of \$51,000.
- The long-term golf course bond will be repaid in two years with a final payment of \$42,000.

Remember, these bond issues were made possible through loans from the General Fund and the Federal Revenue Sharing Fund. Therefore, it makes sense to repay the General Fund in the future for these loans.

What does the new Aquatic 8 Center mean to the citizens of Wood The old Wood River Municipal River? Swimming Pool had been a great landmark and a source for civic pride. generations of swimmers from Wood River and surrounding communities spent a lot of summer days at the pool. pool will always hold a special place in our hearts. We also look forward to completion of our new landmark. The Wood River Aquatic Center will be a place for entertainment. The Aquatic family Center will serve as the keystone of the Central Park Recreation Area for years to come.

Paving a Smoother Way for You

The City has many plans for street maintenance during this summer. If your street is going to be resurfaced, you will receive a notice from the City the day before asking you to move your car off the street. Your street will be blocked off for a short while until it is finished being resurfaced. The alley will be done first and then the street.

All of the following streets will be oiled and chipped, which includes being covered with fresh rock, grated, compacted and then sprayed with primer:

Living in Wood River

\$\$ is a Bargain!\$\$

A recent study in December, 1988 compared the average homeowner costs of City services in the 16 Madison County cities having a population over 1,000. It turned out that living in Wood River is a bargain! Cities were ranked from 1 (most expensive) to 16 (least expensive). Wood River ranked 12th for user fees (water, sewer, refuse collection) and 11th for total taxes (property, utility, wheel). In total, 10 cities were more expensive places to live than Wood River.

Looking at user fees:

Refuse Collection:
Highest Cost -- Maryville & Troy at \$65.
*The average Wood River homeowner paid
\$32 per year, which is no increase over
last year!

Sewer Fees:

Highest Cost -- Maryville at \$112.

*The average Wood River homeowner paid \$48 per year, which is no increase over last year!

Water Fees:

Highest Cost -- Alton at \$156.

*The average Wood River homeowner paid \$85 per year, which is no increase over last year!

Total User Fees:

Highest Cost -- Maryville at \$289.

*The average Wood River homeowner paid \$165 per year, which is no increase over last year and \$124 cheaper than Maryville.

In fact, the average Wood River homeowner paid LESS for total annual user fees than homeowners in Maryville, Glen Carbon, Troy, Bethalto, Granite City, South Roxana, Alton, Highland, Madison, Venice and Edwardsville.

Looking at taxes:

Wheel Tax:

Highest cost -- Troy at \$14.

*Wood River homeowners paid No tax!

Utility Tax:

Highest Cost -- South Roxana and Madison at \$82.

*Wood River homeowners paid NO tax!

Cost-Cutters



The Ghent Water Treatment Facility in our City has been operated on a 24-hour, 365 day basis since it began treating the City's water supply in 1965. Last October, a study was done to see if the number of shifts at the plant could be reduced from 3 to 2. The study proved to be a success!

The daily treatment time of the water depends on how much water is used each day, but the normal treatment times are 8:00 AM to 10:00 PM. Much less water is used during the rest of the hours of the day so water needed can then be supplied by the water towers.

During the unstaffed periods, an alarm system now monitors the facility and storage conditions. The system alerts the Police Dispatcher if a problem arises at the facility. In the case of a fire during the unstaffed period, a water plant operator is called by the Police Dispatcher to go to the plant and resume pumping to maintain adequate water storage.

Reducing the water plant operation to 2 shifts also reduced the number of operators needed at the plant from 4 to 3. The extra operator has been transferred to the Water Distribution Division. This transfer will improve maintenance of the distribution system.

An added benefit to the shift reduction is that no scheduled overtime will be needed (except during periods of exceptionally high water usage). The overall savings to the Water Fund is estimated at \$15,000 per year as a result of changing from 3 to 2 shifts.

Please Permit Me...

Permits for repairs and/or construction are required to protect you and your neighbors. It is important to remember that new additions or alterations to your home generally require a permit from the City. Also, garage and yard sales, and fence construction, require permits.

Here are some basic rules to follow:

Building Permits

- Never <u>assume</u> anything! Before beginning a home improvement project, call City Hall and ask about required permits and fees for any repairs or work on buildings, plumbing, electrical, demolition, patios, and swim pools.
- 2. All permits must be posted at the site where work is being performed.
- 3. The construction of fences requires permits. Maximum heights of fences vary depending on: a) whether the property is in a residential or commercial district, and b) if the property is a corner lot.

Garage & Yard Sales

- Permits are acquired from the City Clerk and must be visible during sales.
- Garage and yard sales can be conducted no more than two (2) times a year on a specific property.
- 3. A garage or yard sale cannot last for more than 72 hours.
- 4. Signs advertising garage sales are not allowed in public right-of-way, such as utility poles, etc.

*Remember, when building additions or making alterations - do not assume anything!! Call City Hall at 254-0123 for more information regarding required permits; taking this precaution can save you time and money - resulting in a well-done job.

Property Tax:
Highest cost -- Venice at \$233.
*The average Wood River homeowner paid
\$137 per year for city services.

In fact, the average Wood River homeowner paid LESS for total annual taxes than homeowners in Granite City, Venice, Maryville, South Roxana, Alton, Madison, Edwardsville, Highland, Bethalto and Collinsville.

The study concludes that, for 16 Madison County cities, total yearly costs range from \$526 down to \$187, with 10 cities being more expensive to live in than Wood River. Wood River is 43% or \$224 LESS EXPENSIVE than the most expensive city to live in. Although Edwardsville and Wood River are very similar in population and tax base, it would cost an average homeowner 15% more, or \$46 for City services in Edwardsville compared to Wood River.



Oh, Rats!

Now is a good time to stop rats from ever becoming a problem in our City. Here are a few tips on how to prevent rats:

- 1) Store trash and garbage in <u>covered</u> containers.
- 2) Keep grass and weeds cut.
- 3) Avoid letting junk accumulate in your yard.
- 4) Store pet food in <u>closed</u> containers and <u>do not</u> leave pet food out over night.
- 5) Cover all openings in buildings, even if they are as small
 as a quarter, using screen or
 metal. Once rats enter a
 building, they gnaw on insulation of wires which can cause a
 fire.

- 1) Please give the City a 1 day advance notice if you want your water turned OFF or ON (for non-emergency situations so our schedule can meet your schedule.
- 2) DO NOT tamper with your water meter or shut-off valves in the street. Court action will be taken as this is considered vandalism to City property. Always call the Water Office at 254-0131 if you need your water turned ON or OFF.

Pay for What You Use--

Did you know that 1 drop of water per second from a leaky faucet can add up to as much as four gallons per day? One leaky faucet can waste as much as 5,000 gallons of water a year or \$6.50. And if it is a hot water faucet that is leaking, you are also wasting the energy it takes to heat the water and your money to pay for that energy.

Toilets that <u>do not stop running</u> are a major problem. Constantly running toilets can use 100,000 gallons of water in 12 months! That is a waste of precious water as well as your \$65 each month.

Keep Wood River Beautiful

The City has hired an additional part-time inspector in an attempt to place special attention on the enforcement of laws pertaining to the upkeep private property. This will help keep our City beautiful.

Our new inspector is Denise Gimmy who will be assisting Woody Haley in this capacity. In order to prevent receiving a citation from the General Inspectors, you could make sure you have none of the following violations:

- Weeds/grass must not grow in excess of 8 inches.
- Unlicensed or inoperable vehicles are not allowed on private property more than 10 days (must be valid license).
- Property must be maintained in a clean, safe and sanitary manner, free from any accumulation of rubbish or garbage.
- Brush must not remain on property.
- Major overhaul of vehicles must not be done in residential area.
- All structures must be maintained structurally sound.
- All wood should be stacked 18 inches above ground.

These are a few of the things the Inspectors will be looking for in all sections of the City. Your help and cooperation will be greatly appreciated.
